Day 1

- Carving equipment and safe procedures
- Planning and setting up
- Special Techniques
- Step-by-step carving a standing eagle
- “feathering” techniques
- Finishing and Protection methods

Day 2

- Carving a standing owl

Day 3

- Carving a small sitting bear

Total Cost is \$400 per person

Including charge of \$30 for three logs

(Some students may prefer to bring their own logs, max 12 inch x 48 inch).

Equipment requirements include:

- Eye, ear, foot and leg protection. Work gloves required when using grinders.
- Small chainsaw (max 35cc or electric) with short (12” max) bar and safety chain.
- Approved container for fuel and oil mixed, chain oil.
- Other hand and power carving tools you may already have.
- Outdoor clothing suitable for the weather.

Recommended equipment:

- Chainsaw with “dime tip carving bar”
- Chainsaw Chaps or pants;
- ear protection with face shield
- Steel Toe work boots
